I would like to take a moment to congratulate ALL the 2020 graduates from the Village of Stickney, from Kindergarten, to Grade School, High School and College.

We would like to welcome our new Chief of Police Jim Sasseti to the Village. Jim has already made some big strides within his Department, and as always, we want to thank Jim and all the men and women of the Stickney Police Department for all they do for our community.

On June 30, 2020, the Village Zoning Board changed the zoning on the East side of town. This will allow Hawthorne Race Course to

now include a CASINO on their property. Thank you to our Zoning Board team with the assistance of our Building Inspector Josh Briak and the Del Galdo Law Group for making this happen.

This Casino Project will be a big asset to our community. There are three phases to this project. The estimated cost to Hawthorne for the first phase is \$390 million dollars. Phase two and three will follow!

The idea of having a casino at Hawthorne has been around for approximately twenty years. Now the State, Hawthorne and our Village are making it happen.

Other refreshing plans, Public Works has been busy continuing to beautify our parks and other areas around town.

It was not an easy task, but we did it. The street was in such bad shape that you could have lost a small mini van in some of the potholes.

This is the first time in many years that there will not be a Family Day. During the Social Distancing caused by the Covid-19 Pandemic, I was able to do remote learning to gather the points needed to accomplish my Master Municipal Clerk designation. This is the second of two professional designations offered by the International Institute of Municipal Clerks. I already achieved Certified Municipal Clerk status in 2014. Each designation requires 60 advanced education points. Points vary by the program taken. The remote learning I was taking earned me one point for two hours of learning. My goal is to have the entire 60 points very shortly. In addition, I took the FEMA Introduction to the Incident Command System Course. As an elected official, we are considered First Responders.

2020 Update

CENSUS

Everyone Counts!

The Covid-19 Pandemic has delayed the schedule with the Census count. Stickney still has many people who have not responded to their 2020 survey.

POSTCARD: An additional reminder postcard will be sent to those who have not yet responded. This postcard will be scheduled to arrive between July 22 and July 28. People are asked to respond online, by phone or by mail. Households can **respond in English or 12 other languages.**

PERSONAL VISITS: Census takers will begin visiting households that haven't yet responded beginning August 11 and ending on October 31. Some households that have already responded will have a census taker visit as part of quality checks on the census. They want to make sure that everyone in a household was counted. All Census takers will be trained on social distancing protocols. They follow all guidelines using personal protective equipment.

POST-ENUMERATION SURVEY TO TAKE PLACE SEPTEMBER 23 TO DECEMBER 22: After a household has already completed the 2020 Census, census takers will visit a select number of households as part of the Census. They will gather the following information:

- Current residents of the housing unit.
- People living in the household who may or may not have been there on April 1 (Census Day).
- People who moved out of the household between April 1 and the time of the interview.

All Census takers have official ID badges that include their name, photograph, a U.S. Department of Commerce watermark, and an expiration date. Be cautious of people posing as Census employees. Real Census employees won't ask for your full Social Security number, for money or donations, or for bank or credit card numbers.

On June 16, 2020 Governor Pritzker signed a law that gives all recent voters in Illinois the ability to vote by mail in the November 3, 2020 Presidential Election. This opportunity came about because of the ongoing COVID-19 pandemic. The legislation also expands early voting hours at permanent polling places, improves the signature verification process and makes election day a state holiday.

According to the Cook County Clerk, any registered suburban Cook County voter may request a mail ballot by filling out an application at www.cookcountyclerk.com web site. To complete the application, you will need:

- your driver's license or state ID number;
- the last four digits of your Social Security Number;
- the address where you would like your ballot mailed; and
- an email address.

The Village of Stickney front office has paper application that you can fill out and mail into the Cook County Clerk's office.

For voters who return their applications early, ballots will be mailed out starting on September 24, 2020, and the voter should receive them no later than October 5, 2020. Additional information concerning Vote by Mail is available at the Cook County Clerk's web site. VISITAS PERSONALES: Los encuestadores comenzarán a visitar hogares que aún no han respondido a partir del 11 de agosto y hasta el 31 de octubre. Algunos hogares que ya han respondido tendrán una visita de encuestadores como parte de los controles de calidad del Censo. Quieren asegurarse de que todos los miembros de un hogar sean contados. Todos los encuestadores del Censo recibirán capacitación sobre protocolos de distanciamiento social. Siguen todas las pautas utilizando equipo de protección personal.

ENCUESTA POSTERIOR A LA ENUMERACIÓN SE REALIZARÁ DEL 23 DE SEPTIEMBRE AL 22 DE DICIEMBRE: Después de que un hogar ya haya completado el Censo 2020, los encuestadores visitarán un número selecto de hogares como parte del Censo. Recopilarán la siguiente información:

- Residentes actuales de la unidad de vivienda.
- Las personas que viven en el hogar que pueden o no haber estado allí el 1 de abril (Día del Censo).
- Personas que se mudaron de la casa entre el 1 de abril y el momento de la entrevista.

Todos los encuestadores del Censo tienen credenciales de identificación oficiales que incluyen su nombre, fotografía, una marca especial del Departamento de Comercio de EE. UU. y una fecha de vencimiento. Tenga cuidado con las personas que se hacen pasar por empleados del Censo. Los empleados del Censo no pedirán su número de Seguro Social completo, dinero o donaciones, ni números de banco o tarjeta de crédito.

Hawthorne petitioned to be zoned as a Rasino, which is a horse track that includes casino gambling. On June 30, 2020, the Village Board met and unanimously passed a text amendment based on the Zoning Board’s recommendation. This text amendment will allow Hawthorne Race Track to include casino gambling.

This project will bring much economic development into our Village. Hotels, restaurants, and other retail outlets are just some of the economic developments in the plans. This development will result in increased tax revenue to our Village, as well as beautify the area. Also, the creation of over 1,000 jobs as a result of the influx of retailers and establishments opening in our Village.

**Village of Stickney
Tree Ordinances:**

Planting trees on public property: A permit is necessary to plant a tree on

any public parkway. Applications for permits are available through the building department. All applications are approved by the Tree Board and Village Supervisor.

A permit is necessary for removing a tree on private property if it exceeds eight feet in height. Tree removal services on private property must be duly licensed and bonded. Property owners are responsible for the disposal of trees that have been removed from private property.

The following trees are not allowed to be planted in the Village of Stickney

- 1) Ailanthus-Tree of Heaven
- 2) Morus-Mulberry
- 3) Catalpa-Catalpa
- 4) Muclura-Osage Orange
- 5) Populus-Poplar; Cottonwood
- 6) Salix-Willow
- 7) Acer negundo-Box Elder
- 8) Ulmus (chinensis)-Chinese Elm
- 9) Ulmus American Moline-Moline Elm
- 10) Ulmus Americana-American
- 11) Populu Nigra Italica-Lombard Poplar
- 12) Ash of any kind

Please refer to Municode.com for all other tree ordinances.

Tree Lottery: There will be a tree lottery for Village residents. Applications will be available during the month of September at the Village Hall or on the Village website at www.villageofstickney.com. Information regarding the type of trees and quantity will be available with the application. Winners of the lottery will be notified after Labor Day and trees will be planted at the end of September or early October.

The Police Department was made up of all men, white men. Thirty-two years-ago I was approached to be a female Reserve Officer and translator for the department. It was a great and scary opportunity for me. I went back to school, Morton College and received my Associates Degree in Law Enforcement. I wanted to be the best at what I do. The reason I am telling this story is because the Stickney Police Department has come a long way. We have a very diverse department. We have more Spanish speaking officers and women police officers. In fact, we have our first female Corporal this year.

This diversity allows for a better community. The Stickney Police Officers work well with our residents. They uphold the law as well as help the families, children, and people who live in Stickney

We were fortunate not to have any riots here. I thank the Mayor and Police Chief for their commitment to maintaining a great Village. It takes a lot of work and continued support from everyone. It shows what a great village we are, and an excellent place to live!

First, I must express how humbled and honored I am to be here. The Stickney Police Department is a great organization with a long and esteemed history that I am proud to now be a part of. I have been in law enforcement for over twenty-five years and during that tenure, I am fortunate to have served in many different assignments, units and task forces. I am a strong advocate for community policing initiatives and have built and grown successful programs. It's my intention to broaden our community policing initiatives and involve the community on a larger scale.

Since being appointed, I have conducted a top to bottom evaluation of the police department. As a result of that assessment, I have made some organizational modifications to increase operational efficiency. The Stickney Police Department has added a second Deputy Chief. One Deputy Chief is responsible for administrative functions and the second Deputy Chief will be responsible for operational functions. By delegating resources, we can operate more effectively thus providing enhanced services to the community. We have made numerous technological strides in a short period of time. The Stickney Police Department is now on the Ring Neighbors App thus giving us an additional technology resource in seeking and disseminating information to and from the community. The Ring Video Doorbell lets you see, hear and speak to people from your phone, tablet, or select Echo Devices. You do not have to have a Ring Doorbell to have the App. We have increased our social media footprint which in turn provides the community with an increased stream of real time information. Like us on Facebook at Stickney Police Department to be connected.

As we enter into the fall season, it is anticipated that schools are going to re-open. Therefore, the police department will increase its presence and traffic enforcement initiatives around area schools. Remember, Stickney Village Ordinance Sec. 14-52 prohibits using alleys as thoroughfares so please drive safely and utilize the adjacent streets around schools to drop off and pickup children. We are still in the midst of the COVID-19 pandemic; the CDC identifies social distancing and the wearing of face masks as one of the key ways to stop the spread of the virus so please continue to follow these recommendations. Also, due to COVID-19, our officers continue to work based on a modified response plan so we recommend residents utilize our report by email service for non-emergency police reports. To file a non-emergency police report, send an email to: fileareport@stickney-police.com and include your name, address, the type of situation you are reporting and attach photos (if applicable). An officer will contact you with a report number and solicit any follow-up information if required. Please **DO NOT** utilize this service for emergency situations, call 911 for all emergencies.

Document Shredding and Small Electronics Recycling Day

On Saturday, August 22nd, the Village along with Waste Management will be sponsoring a Document Shredding and Small Electronics Recycling Event from 9:00 a.m. to Noon at 41st and Ridgeland Avenue. Waste Management will provide locked containers that will be used for the documents. We will have volunteers on site to assist you in depositing your documents into the locked containers. The containers will be hauled away by Waste Management and they will provide a certificate confirming that all documents have been shredded. **THIS EVENT IS FOR RESIDENTS ONLY.**



Leaf Pick Up

Leaf Pick up will begin the last week of October through December on Mondays and Tuesdays only. Leaves should be placed loose along the curb in front of residents' home. This pick up is for leaves only - do not add any other kind of yard waste materials such as grass clippings, branches, flowers or any other kind of vegetation.

Follow the street sweeping signs on your block.

- Monday: The North and West side (even side)
- Tuesday: The South and East side (odd side)

Vehicles may not be parked from 8:00 a.m.-5:00 p.m. or until all the leaves are picked up on your block. All violators will be ticketed and possibly towed at owner's expense.

Please note, this is a separate program from the yard waste disposal. If you still choose to bag your leaves they must be put out on your yard waste pick-up day. Leaves cannot be burned in the Village.

Waste Management Fall/Winter Observed Holidays

Labor Day • Thanksgiving Day
Christmas Day • New Years Day

When your collection falls on or after one of these holidays, your service will be delayed one day during that week only.

Snow Removal - What Happens When It Snows?

- 1) First, main streets and main intersections are plowed and salted. This would include Ridgeland, Oak Park, 40th, 41st, 42nd, 43rd, 44th and 45th streets
- 2) Next all North and South streets and 40th place will be cleared
- 3) Public facilities which will include the parking area for businesses along Pershing Road
- 4) Parks and Bus stops
- 5) We do not do any snow removal on Pershing Road because it's a state route

When snowfall measures two inches or more you must follow the snow removal signs posted at the beginning and towards the end of your block. Snow Removal hours are from 8:00 a.m. – 11:00 p.m.

Public Works cannot be called to clear private property or driveways, and we are not responsible for rollover snow on driveways or sidewalks from snowplowing.

Please be courteous to your neighbors and motorists; **DO NOT SHOVEL SNOW BACK INTO THE STREETS. THIS IS DANGEROUS AND CAN CAUSE ACCIDENTS AND IT'S AGAINST THE LAW. YOU WILL BE SUBJECT TO A FINE.**

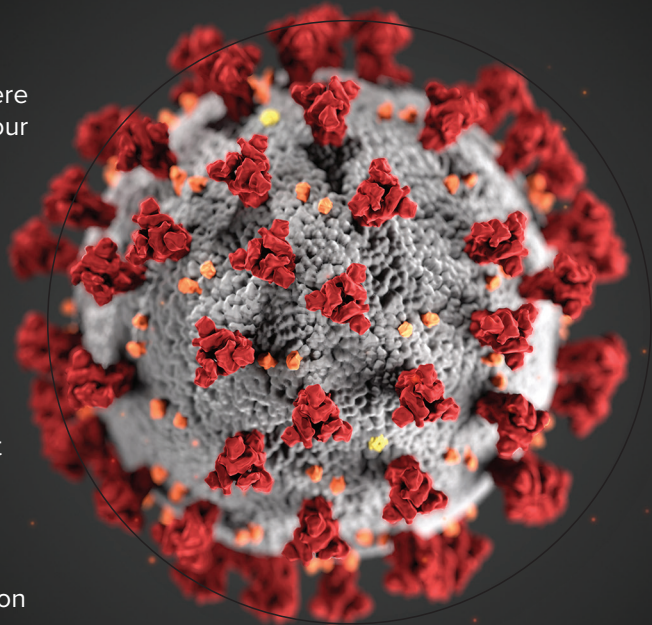

COVID-19

While we are still dealing with the effects of the COVID-19 there are certain things you can do to protect yourselves and your loved ones.

- Know how COVID-19 spreads
- Wash your hands often
- Avoid close contact-social distance-at least 6 feet of distance between yourself and others
- Cover your mouth and nose with a cloth face cover when around others
- Cover coughs and sneezes
- Clean and disinfect frequently touched surfaces at least daily
- Monitor your health daily

Outdoor-Fall Fire Safety Tips

- Clear your roof and gutters of unnecessary buildup of debris, such as pine needles and leaves.
- Keep Fire Pits at least 15 feet away from any structure and keep either a fire extinguisher, bucket of water or garden hose nearby. After you are finished put the fire out completely with water.



Safety matters

There is nothing more important than the safety of your family. Everyone in your home needs to know how to behave responsibly to reduce the likelihood of experiencing a fire. However, because fires can start at any time without warning, it is also very important that the members of your household know how to react in the event of a fire. It's a good idea to review fire prevention and safety tips with your family every fall, and several other times throughout the year.

EXCESS/OVERFLOWING GARBAGE AND RECYCLING:

Besides causing all sorts of health and environmental issues, overflowing garbage is a public nuisance and eye sore. Everyone wants to live and visit places that are fresh, clean and healthy.

The Village of Stickney has “no side garbage, closed lid procedure”. Closed lid means your garbage bin must be shut completely. If your bin is over-flowing and you have extra garbage left at the side of your bin you are at risk of receiving a ticket. If you have too much garbage and your can is overflowing then you could be required to purchase a second garbage can. This applies to recycle cans as well.



FALL/WINTER CLEANING:

Inspections for upkeep and maintenance of your property will continue throughout the winter months weather permitting. Make sure you clean up any accumulation of junk, debris or litter on private property. Do not store wood or lumber on the ground. It must be kept stored at least 10” off the ground. Be sure to keep the area clean around your garbage and recycling cans. I have seen tires put out for garbage pick-up. Waste Management and our Public Works will not pick up tires. Tires must be disposed of at your own expense. Do not store tires on your property.

RODENTS



There are many things that you can do to avoid having a problem with rodents. Rats are attracted to dog feces, so it is important to clean up after your dog. Do not leave any dog or cat food outdoors. Bird feeding is allowed but must be contained in approved bird feeders and not thrown on the ground. Do not put out corn feed or peanuts, pieces of bread for the squirrels or any other animals. Rats will travel long distances to feed on these types of food.

Always keep your garbage contained and not in plastic bags outside of the container. Contact Village Hall if you need a second garbage container. You can purchase one for \$75. If you suspect a rodent problem on your property, call the Village Hall, we will record the problem, and then notify Environmental Health.

In the past there have been issues with raccoons, skunks, and even coyotes. Most of the time they're just passing through. Keep in mind that unless these animals are living on your property there is not much that can be done. Keeping your property clean of debris, and garbage contained will help avoid such problems.

ATTENTION DOG OWNERS:

All cats and dogs must be registered in town and should have current vaccinations. Current Village tags and vaccination tags must be visible at all times.





Vehicle stickers and pet tag sales has been extended through Monday, August 31st, 2020

Vehicle stickers must be displayed by September 1st. Late fees are an additional \$20.00 per vehicle. Your pet must have a current rabies vaccine number and expiration date in order to obtain a pet license. Late fees are an additional \$5.00 per pet.

We will be open on Saturday, August 22, 2020 from 9:00a.m.-3:00p.m. The Village Hall re-opened on June 3rd with modified hours from 9:00a.m.-3:00p.m. Monday-Friday. This allows extra time to thoroughly disinfect and clean at the end of each day with the safety of our employees and patrons remaining the number one priority. We will continue to be open with modified hours through the end of August and will reassess things at that time.

Village Fall/Winter Holiday Schedule

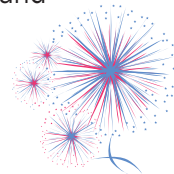
